RE: TRAFFIC REPORT – February 2025

The following is a summary of the activities that have occurred during the month, as well as a summary of the collision, citation and DUI statistics for the Police Department.

### **TRAFFIC COMPLAINTS**

There were no scheduled traffic complaints for the month of February.

### **MONTHLY DUI REPORT**

Two (2) arrests were made for Driving Under the Influence during the month of February. One of the arrests was the result of a traffic collision.

### **TRUCK ENFORCEMENT DATA**

No truck stop enforcement details were performed during the month of February.

## **TRAFFIC OFFICER SCHEDULE**

Sergeant Metzger and Officer MacDonald were assigned to the Traffic Division during the month of December. These officers utilized their police motorcycles and worked traffic enforcement as time and calls for service permitted.

Sergeant Metzger was scheduled for 132 hours and produced a total of 97 citations. Officer MacDonald was scheduled for 96 hours and produced a total of 54 citations. During the month of February, Officer Rojas was assigned to night shift as a supervisor and was not on duty for the purposes of traffic enforcement.

## **TRAFFIC COLLISION DATA**

During the month of February, a total of four (4) traffic collisions occurred in the Town of Atherton. One (1) of the collisions involved injuries. One of the collisions involved a driver who was driving under the influence.

Vehicle #2: southbound El Camino Real
4. In Front of 66 Virginia Ln (Non-injury/ Hit Object)  
Tuesday, 11:40 AM, Unsafe Turn  
Vehicle #2: northbound Virginia Ln

None of the above collisions occurred during the morning commute period, 6:00am to 10:00am, Monday through Friday.

Two (2) occurred during the afternoon commute period, 3:00pm to 7:00pm, Monday through Friday.
