RE: TRAFFIC REPORT –DECEMBER 2023

The following is a summary of the activities that have occurred during the month, as well as a summary of the collisions, citations, and Driving Under the Influence (DUI) statistics for the Police Department.

### **TRAFFIC COMPLAINTS**

The Atherton Police Department did not receive any traffic complaints for the month of December.

### **MONTHLY DUI REPORT**

No arrests were made for Driving Under the Influence during the month of December.

### **TRUCK ENFORCEMENT DATA**

No truck stop enforcement occurred during the month of December.

### **TRAFFIC OFFICER SCHEDULE**

Sergeant Metzger, Officer Rojas, Officer MacDonald, and Officer Gatto were assigned to the Traffic Division during the month of December. These officers utilized their police motorcycles and worked traffic enforcement as time and calls for service permitted.

Sergeant Metzger was scheduled for 192 hours and produced 180 combined cites.  
Officer Rojas was scheduled for 77 hours and produced 52 combined cites.  
Officer MacDonald was scheduled for 132 hours and produced 68 combined cites.  
Officer Gatto was scheduled for 164 hours and produced 87 combined cites.

## **TRAFFIC COLLISION DATA**

During the month of December, a total of three (3) traffic collisions occurred in the Town of Atherton. One (1) of the collisions involved injuries. None of the collisions were hit-and-runs. None of the collisions involved a driver who was driving under the influence.

The collisions occurred in the following locations:

- 1) Valparaiso Avenue at the intersection of Crane Street  
Wednesday, 5:45 PM, Broadside, Failure to Yield  
Vehicle #1: Northbound on Crane Street  
Vehicle #2: Westbound on Valparaiso Avenue  
Vehicle #3: Eastbound on Valparaiso Avenue
- 2) Oak Grove Avenue at the intersection of Middlefield Road  
Thursday, 2:19 PM, Broadside, Failure to Yield  
Vehicle #1: Eastbound on Oak Grove Avenue  
Vehicle #2: Westbound on Oak Grove Avenue
- 3) Middlefield Road at the intersection of Glenwood Avenue (Minor Injury)  
Sunday, 1:20 PM, Head On, Unsafe Turning Movement  
Vehicle #1: Eastbound on Glenwood Avenue  
Vehicle #2: Southbound on Middlefield Road

Of the above collisions, none occurred during the morning commute period, 6:00am to 10:00am, Monday through Friday.

Of the above collisions, one (1) occurred during the afternoon commute period, 3:00pm to 7:00pm, Monday through Friday.
