RE: TRAFFIC REPORT –NOVEMBER 2023

The following is a summary of the activities that have occurred during the month, as well as a summary of the collision, citation, and driving under the influence (DUI) statistics for the Police Department.

TRAFFIC COMPLAINTS

The Atherton Police Department received one (1) traffic complaint for the month of November.

- 1) A resident reported commercial vehicle violations on Glenwood Avenue Monday-Friday from 8:00 a.m. to 9:30 a.m.

MONTHLY DUI REPORT

No arrests were made for Driving Under the Influence during the month of November.

TRUCK ENFORCEMENT DATA

No truck stop enforcement occurred during the month of November.

TRAFFIC OFFICER SCHEDULE

Sergeant Metzger, Officer Rojas, Officer MacDonald, and Officer Gatto were assigned to the Traffic Division during the month of November. These officers utilized their police motorcycles and worked traffic enforcement as time and calls for service permitted.

Sergeant Metzger was scheduled for 144 hours and produced 156 combined cites.
Officer Rojas was scheduled for 129 hours and produced 111 combined cites.
Officer MacDonald was scheduled for 104 hours and produced 79 combined cites.
Officer Gatto was scheduled for 130 hours and produced 29 combined cites. During this month, Officers attended the Asia-Pacific Economic Cooperation (APEC) in San Francisco. The traffic officers provided police escorts for the President of The United States.

TRAFFIC COLLISION DATA

During the month of November, a total of six (6) traffic collisions occurred in the Town of Atherton. Three (3) of the collisions involved injuries. One (1) of the collisions was a hit-and-run. None of the collisions involved a driver who was driving under the influence.
