# 3.100 Introduction

## Revisions include:

- Standardized Headings and References for Tables and Figures
- Updated Locator Map
- Income Categories Transparency

# 3.200 Assessment of Housing Needs

## Revisions include:

- Expansion of Section 3.210 (Housing Needs Detailed Analysis)
  - *Use of MTC/ABAG data to assert consistency with other jurisdictions*
- Overview of Section 3.211 (Summary of Key Facts)
  - *Providing context for section*
- County and Regional Comparisons
  - *Add or clarify comparative data and analysis for demographic data*
- Special Housing Needs
  - *Expand analysis for each population group requiring special housing needs*

# 3.300 Atherton Fair Housing Assessment

## Revisions include:

- Updated Section 3.321 (Primary Findings)
  - *Updates to summarize Fair Housing Assessment*
- Expanded Section 3.330 (Outreach and Capacity)
  - *Identifies how the town receives, compiles and refers fair housing complaints*
  - *Indicates how the town will proactively conduct educational outreach to increase awareness of fair housing rights*
- Housing Specific Policies Enacted Locally
  - *Removed partial list of housing policies under consideration by Council*
  - *This information is included in other section that provide a full list of housing programs and policies*

# 3.300 Atherton Fair Housing Assessment

## Revisions include:

- Barriers to Housing
  - *Section 3.300 previously included a discussion of barriers to housing in Atherton*
  - *This section will be relocated to Section 3.500 (Constraints on Housing)*
- Integration and Segregation
  - *Section 3.340 includes more data and analysis on socio-economic patterns in Atherton, San Mateo County, and Bay Area region*
  - *This is required by HCD to fully explore all potential housing needs in town*
  - *Discussion of Racially or Ethnically Concentrated Areas of Poverty and Affluence (R/ECAP & RCAA) moved from 3.350 to 3.340 to facilitate robust consideration of all indicators of integration and segregation*

# 3.300 Atherton Fair Housing Assessment

## Revisions include:

- Local Data and Knowledge
  - *Moved from Section 3.330 to Section 3.380 and expanded to address history of zoning and land use, as well as impacts on fair housing issues as required by HCD*
- Access to Opportunity
  - *Section 3.350 discusses disparities in access to opportunity as required by HCD*
  - *This will assist in identifying:*
    - Constraints on housing for low-income households and special needs populations, especially persons with disabilities
    - Cost-burdened households within the town

# 3.600 Review of the 2015-'22 HE Performance

**Similar to Annual Progress Reports (APRs), this section compiles all APRs for previous (5<sup>th</sup>) Cycle and assesses effectiveness**

**Revisions include:**

- Table HE-11 (Analysis of the Objectives and Programs Contained in the 2015-2022 Housing Element Update
  - *Relocating text analysis that was embedded in table to ease HCD review*
- Special Populations
  - *Additional analysis of special needs populations, as required by state law*
