**A RESOLUTION OF THE CITY COUNCIL OF THE TOWN OF ATHERTON
ADOPTING THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017 (SB1)
PROJECT LIST AND AMENDING GAS TAX APPROPRIATIONS FOR FISCAL YEAR
2023-2024**

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 in order to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our Town are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the Town of Atherton must adopt by resolution a list of all projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, in the Town budget, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the Town, will receive an estimated \$169,000 in RMRA funding in Fiscal Year 2023-24 from SB 1; and

WHEREAS, this is the fifth year in which the Town will be receiving SB 1 funding and will enable the Town to continue essential road maintenance and rehabilitation projects; and

WHEREAS, the Town uses a Pavement Management System to assist in developing the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities priorities for transportation investment; and

WHEREAS, the adoption of the Town's RMRA project list is not a "project" as defined by Public Resources Code section 21065 because it is not an activity which may cause either a direct physical change in the environment, or a reasonably foreseeable indirect physical change in the environment, thus no environmental review is required under the California Environmental Quality Act, Public Resources Code section 21000, et seq.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the Town of Atherton hereby find the foregoing recitals are true and correct and hereby adopts the attached SB1 project list for Fiscal Year 2023-24, incorporated as though fully set forth herein, to be funded in-part or solely with fiscal year 2023-24 Road Maintenance and Rehabilitation Account revenues.

FY 2023-24 SB-1 Project List

Project Description:	The project is to grind two-inch of existing asphalt and overlay with new asphalt, and/or cape seal/micro-surface seal various streets in the Town of Atherton. Specific locations, listed below, have been identified through an engineering survey conducted by independent assessors of pavement conditions. The overlay and cape seal/micro-surface seal maintenance strategies for each location are based on the assessed pavement conditions.
Project Locations:	The project will be for various roadways which are listed below:
Overlay:	Tuscaloosa Ave. – Between El Camino Real and Austin Avenue
Micro-Surface Seal:	N/A
Scheduled Completion:	Project construction is planned to be completed by October 31, 2023, for Fiscal Year 2022-23.
Estimated Useful Life:	5 years for Micro-Surface Seal and 10 years for Overlay
