# **PUBLIC HEARING (Items 10 – 10)**

10. APPEAL OF A PLANNING COMMISSION DECISION TO DENY A VARIANCE TO ALLOW FOR A FENCE/WALL TO EXCEED SIX FEET IN HEIGHT AND TO ALLOW FOR A RETAINING WALL TO BE LOCATED LESS THAN FIVE FEET FROM THE PROPERTY LINE AT 25 ISABELLA DRIVE.

Town Planner Kwon introduced the item and provided a brief history.

Ms. Yu and her representatives presented to City Council reviewing their argument in support of granting the variance.

Jim Heslin addressed the City Council reviewing his argument against the Council granting the variance noting a few municipal code violations.

City Council asked both parties the results from the mediation process that was recommended at the prior hearing and the response was that they could not come to an agreement on the final plans.

City Attorney Ebrahimi provided clarification related to the Public Hearing and reviewed the options available to the Council. She noted that the Council would be specifically voting on the variance application for the fence.

MOTION by Widmer Lewis, Second by Polito to deny the appeal, and uphold the decision of the Planning Commission to deny the Variance application at 25 Isabella Drive to allow a fence to exceed six (6) feet in height and a retaining wall to be located less than five (5) feet from a property line for the reasons stated below.
