**CENTER WARM WATER THERAPY POOL** 

## **RECOMMENDATION**

Adopt a Resolution in Support of Reopening the Mack E. Mickelson Arthritis and Rehabilitation Center Warm Water Therapy Pool Located at the Mills Health Center in San Mateo, California.

#### **BACKGROUND**

In June of 2021, Sutter Health announced that it would permanently close the Therapy Pool located in the Mack E. Mickelson Arthritis and Rehabilitation Center, which has operated for over 25 years and has been used over the years by thousands of residents of San Mateo County who suffer from a broad range of health issues, including permanent disabilities, debilitating injuries, autoimmune disorders, and mobility impairments.

During the City Council meeting on November 16, 2022, a member of the public requested that the Council consider adopting a resolution in support of reopening the Mack E. Mickelson Arthritis and Rehabilitation Center Warm Water Therapy Pool.

### **ANALYSIS**

As discussed, the Mickelson Therapy Pool has historically provided both preventative and interventionist therapies to residents of San Mateo County suffering from health issues and it is an asset to the community at large and even more so to residents who are elderly or who live with mobility impairments and health conditions.

Sutter Health and its subsidiaries and affiliated entities receive significant financial benefits from their operations in San Mateo County, including from both public and private contracts. Over 4,300 patients, caregivers, and community members have signed a petition to reopen the Mickelson Therapy Pool in order to increase the health, independence, and dignity of those residents who rely

upon it. Warm water therapy pools in the region can and do operate profitably and safely under relevant COVID-19 regulations. Additionally, 16 jurisdictions in San Mateo County and the County have adopted a resolution calling on Sutter Health to reopen the Mack E. Mickelson Arthritis and Rehabilitation Center Warm Water Therapy Pool with the same open access hours, for community use, that it had prior to January of 2020.

No additional actions are being asked of the Town beyond adopting a resolution in support of reopening the Mickelson Warm Water Therapy Pool. If the Town were to adopt a resolution, the Town's resolution would be added to Warm Water Wellness' website on the Community Support page.
