## **RESOLUTION NO. 22 - XX**

## A RESOLUTION OF THE CITY COUNCIL OF THE TOWN OF ATHERTON DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD IN THE TOWN OF ATHERTON ON NOVEMBER 8, 2022

WHEREAS, a General Municipal Election was held and conducted in the Town of Atherton, County of San Mateo, State of California, on Tuesday the eight day of November, 2022, as required by law, for the purpose of electing three members of the City Council for the full term of four (4) years each; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provided by law, voting precincts were properly established, election officers were appointed and in all cases said election was held and conducted and the votes cast were received and canvassed and the returns made and declared in the time, form and manner as required by the provisions for the Elections Code of the State of California for holding of elections in cities; and

WHEREAS, pursuant to Resolution No. 22-15, the County of San Mateo Election Department canvassed the returns of said election and has certified the results, which are attached and made a part hereof as "Exhibit A".

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the Town of Atherton resolves as follows:

**Section 1:** That the total number of ballots cast in the vote centers and vote by mail ballots was 3,224

<u>Section 2:</u> Said General Municipal election was held for the purpose of electing three (3) members of the City Council for four-year terms.

**Section 3:** The names and results of the persons voted for at said election for members of the City Council are:

**Section 4:** The City Council does declare and determine that:

Rick DeGolia was elected as a member of the City Council for a term expiring upon the election of a successor thereto at the General Municipal election in November 2026.

Bill Widmer was elected as a member of the City Council for a term expiring upon the election of a successor thereto at the General Municipal election in November 2026.

Stacy Miles Holland was elected as a member of the City Council for a term expiring upon the election of a successor thereto at the General Municipal election in November 2026.

**Section 5:** The city clerk shall deliver to each person elected a certification of election signed by her and duly authenticated; she shall also administer to the persons elected the oath of office as prescribed in the State Constitution of the State of California and shall have those persons subscribe thereto and file it in the office of the city clerk. Each person so elected shall be inducted into the office which he or she has been elected.

**Section 6:** The city clerk shall enter in the records of the City Council a statement of the results of said election, showing (1) the whole number of votes cast in the city; (2) the names of the persons voted upon; (3) the office for which each person was voted for; and (4) the number of votes given to each person. These results are attached as *Exhibit A* to the resolution.
