**REGULAR AGENDA (Items 10 – 11)** 

10. AN ORDINANCE OF THE CITY COUNCIL OF THE TOWN OF ATHERTON AMENDING CHAPTER 8.16 (NOISE CONTROL) OF THE ATHERTON MUNICIPAL CODE.

City Manager Rodericks introduced the item noting the rules and noise level allowances and exemptions of a few neighboring cities surveyed.

City Attorney Ebrahimi added context related to the infraction language included in the Ordinance subjecting the punishment to a Misdemeanor.

Council expressed some reservations related to the penalties and fines and held a discussion about the noise levels for certain times of the week/day and modifications of the Town's Social Gathering dBA limits, enforcement and penalties.

Chief McCulley addressed a few council inquires related to the type of social gatherings that take place in Town and the severity of the noise issues. He commented that it is not a significant issue in Town.

Council provided direction to make minor revisions to penalties to allow for additional discretion during enforcement. This item will be return for a first reading and introduction at the Council December Regular Meeting.

# 11. RECOMMENDATION FROM THE TOWN'S AUDIT AND FINANCE COMMITTEE TO BEGIN PAYING THE RETIREE OPEB HEALTH BENEFITS FROM THE TOWN'S PARS TRUST ACCOUNT

City Manager Rodericks introduced the item and provided additional options for Council consideration in contributing to the OPEB health benefits from the Towns PARS Trust accounts.

Council Member Widmer and Polito commented the process the Town will take in making annual contributions to the Trust along with the payments.

Council discussed issues related to the rates of investment return, use of funds once payments are shifted to the OPEB Trust, identification of savings opportunities, and actuarial reporting.

Finance Director Barron III reviewed the PARS Trust Account investment strategies.

Council directed that staff account for the General Fund savings in a manner that allows for a use of the funds can be singular identified as a part of the budget process.

MOTION by Polito, Second by Lewis to approve recommendation from the Town's Audit and Finance committee to begin paying the retiree OPEB health benefits from the Town's PARS Trust account as soon as reasonably possible
