American Green Zone Alliance Workshop for Professionals Transitioning to Battery Electric Land Care Equipment and Operations

The American Green Zone Alliance (AGZA) is pleased to submit this workshop proposal to the Town of Atherton. This workshop will provide outreach, education, and resources to help Atherton and surrounding area professional landscape maintenance crews transition operations away from less fossil fuel-powered equipment to battery electric and people-powered alternatives. Transitioning to battery electric equipment and people-powered tools generate meaningful reductions in noise, and emissions, benefitting the health of workers, and the public, and improving the quality of life in Atherton.

Our goal is to work collaboratively with the Town of Atherton and private professional maintenance companies to help facilitate positive outcomes for the future. Conducting an AGZA workshop for local professionals and the community demonstrates Atherton's commitment to quality of life for its residents and positions Atherton as a sustainability leader in the State of California and beyond by actively introducing viable solutions towards clean, quiet, and sustainable landscape maintenance practices for professionals conducting business in the community.

AGZA's workshop will be a 4.5 - hour training in both a classroom and outdoor setting. By the end of the workshop, attendees will understand current regulations (including any Town specific ordinances), an introduction to low-impact landscape maintenance and operations, the ability to access funding mechanisms to lower the cost of battery-powered equipment and be inspired by the potential that their industry must lead and shape their future.

Workshop Content

AGZA "Classroom" Component Electric Operations: Emphasizes the importance of training and certification, satisfying aesthetic expectations, and reaching a Return on Investment. Specific topics covered include the following:

- Impact reduction and benefits
- Battery electric basics
- Infrastructure and charging
- Work productivity considerations
- Economics (ROI, Downstream savings, cost-effectiveness)
- Case studies

Attendees will learn about the current CA State Regulations AB1346 and the Clean Off-Road Equipment Voucher Incentive Project (CORE) for private small businesses to take advantage of price discounts on commercial electric equipment. Additionally, any other area incentive programs will be introduced.

Hands-on field demonstration: AGZA will arrange for an outdoor demo and field tutorial of commercial-grade battery-electric handheld tools and mowers, including:

- Large and small mowers (including robotic)
- Blowers
- Line trimmers/weed whips
- Hedge trimmers
- Stick edgers
- Pole saws, rear handle, and top handle chain saws
