RESOLUTION GOVERNINING TOWN COMMITTEES AND

**COMMISSIONS** 

#### RECOMMENDATION

Review and consider revising Resolution No. 22-01 Governing Town Committees and Commissions to amend the meeting schedule for the Rail Committee from every other month to quarterly.

## **BACKGROUND**

The City Council last amended the Committee Governing Resolution, approving Resolution No. 22-01 at the January 19, 2022, Regular Meeting. The most recent amendments revised the language allowing City Council liaisons to serve on the Audit and Finance Committee other than the Mayor and Vice Mayor.

## Rail Committee

The Rail Committee currently has a meeting scheduled for every other month. The Council discussed revising the status of the Committee from a Town Committee to an independent Committee at the September 21, 2022, Regular Meeting. The Council opted to maintain the Committee's present status and revise its meeting schedule to meet once per quarter.

#### Proposed Revised Language:

"The Committee typically meets once per quarter..."
