The following is a summary of the activities that have occurred during the month, as well as a summary of the collision, citation and DUI statistics for the Police Department.

### **TRAFFIC COMPLAINTS**

The Atherton Police Department did not receive any traffic complaints for the month of November.

### **MONTHLY DUI REPORT**

Two (2) arrest was made for Driving Under the Influence during the month of November. None of the arrests were the result of traffic collisions.

### **TRUCK ENFORCEMENT DATA**

The following is a summary of the activities that have occurred during the month, as well as a summary of the collision, citation and DUI statistics for the Police Department.

### **TRAFFIC COMPLAINTS**

The Atherton Police Department had one traffic complaint for the month of December. The location was Selby Ln at the intersection of Austin Ave. regarding vehicles not stopping at the stop sign during the hours of 6AM and 7AM. From 12/20/2024 to 12/27/2024 officers spent approximately two hours of enforcement in the area. During this time a total of four motorists were contacted for not stopping at the stop sign.

### **MONTHLY DUI REPORT**

Two (2) arrests were made for Driving Under the Influence during the month of December. None of the arrests were the result of traffic collisions.

Wednesday, 8:30AM, Property Damage only, Unsafe Speed  
Vehicle#1: northbound Middlefield Rd
